

202 ANNUAL REPORT Dear Chamber members,

As we look back on the year 2021, our Annual Report tells a story of cautious optimism in the face of uncertainty and change. Nearly two years ago from the writing of this letter today, the World Health Organization declared a global pandemic and brought life as we knew it to what felt like a screeching halt.

However, prudent management by state leadership, local government and businesses, and the community as a whole has brought eastern Connecticut to a state of new normal, characterized by collaboration, adaptability, and tenacity in overcoming overwhelming obstacles. Thanks to board leadership we were able to ensure the smoothest possible recovery and transition to a "post-Covid" community.

We were also pleased to bring back in-person events after a mandatory hiatus, taking into account new procedures to keep our members and staff feeling safe and comfortable. We saw the greatest successes with our outdoor Golf Tournament in June, our long-postponed Citizen of the Year banquet honoring Michael Rauh, and our July Garden party celebrating two years' worth of regional Chamber award, or ECTys, winners. It was truly refreshing to see faces out from behind a computer screen or a mask, when appropriate, and replace a "thumbs up" icon on Zoom with an actual fist bump, handshake, or even a hug.

We continued to strengthen the Chamber's partnerships, including our administrative oversight of Eastern Regional Tourism District. Addressing the devastating hurdles placed in front of the hospitality industry, the Eastern Regional Tourism Board, administered by Chamber staff launched a matching grant program to support creative, collaborative initiatives that was leverage by state and private dollars to increase travel within and to eastern Connecticut.

Bolstered by the support of our Regional Benefactors and over 1,300 dedicated chamber members, the Chamber was able to maintain robust communications, offering up-to-date guidance and resources, host important forums to connect industry peers with each other and with policymakers, and adapt our event and service offerings to better serve our constituency.

The Chamber was not alone in these efforts, and we would be remiss if we did not thank our essential workers for their continued service to the community. Despite understandable trepidation, this important population of professionals kept our community safe and functioning while the pandemic regrettably plodded on.

Finally, I wish to thank all of you who are reading this today, for the Chamber of Commerce of Eastern Connecticut could not exist without your engagement, and your unwavering dedication to your own businesses and organizations. We are here to serve this wonderful region, having done so for over 110 years now, and we look forward to a continued the tradition of meaningful support and economic growth.







#### Eastern Regional Tourism District

The Chamber of Commerce of Eastern CT and the Eastern **Regional Tourism District's** partnership in 2021 continued to provide energized collaboration towards the District's tourism goals and objectives. On June 30, 2021, the Chamber and District renewed their partnership agreement through the end of June 2023. As the Administrative Partner for ERTD. the Chamber continued its diligent work and ensured all operational needs were met including fiscal spending, meetings, adherence to Connecticut Statutes, accuracy in all measures of reporting, and demonstrated leadership within the tourism industry.

In 2021, the District granted \$55,000 in funds to local tourism entities through the Regional Marketing Partnership Program. Criteria to receive a portion of the funds from this grant required collaborators to match the grant with a one-to-one ratio.The District was pleased to be able to saturate Eastern CT's tourism marketing with a total of \$110,000 in funding from private and ERTD grant funding.


#### Offshore Wind

"Embracing the Potential of Offshore Wind in Connecticut A Study of Opportunities and Challenges," was commissioned by the Joint Venture created by Ørsted and Eversource to build the state's first offshore wind farm and was overseen by the Chamber of Commerce of Eastern Connecticut. The Chamber hired McAllister Marine Engineering, LLC of Rhode Island to provide the research and produce the report which is available on the Chamber's website. Overall. New London's proximity to offshore wind lease sites in the Northeast, and its deep-water port offering quick, unobstructed access to open water is the most significant attraction to the industry. Additionally, the study finds that the existence of a robust, high-tech supply chain serving submarine manufacturer General Dynamics Electric Boat and the state's aerospace industry makes the state a prime location to serve as a hub for East Coast offshore wind projects. Said Tony Sheridan, "The findings of this report provide a great value to the state and the industry. It has has given us an objective, unvarnished look at the status of the industry in **Connecticut and the Northeast,** the economic opportunities available, our related advantages in attracting those opportunities, and potential challenges to realizing the maximum potential offered by offshore wind power"

#### Cost-Saving Programs

The Chamber's group health insurance program through Morin Associates continued to be a popular offering to manage employee healthcare costs while providing robust benefits to recruit and retain talent. In 2021, members saved a combined \$394,581 by switching to the Chamber's program.

The Chamber also introduced a 401(k) Multiple Employer Aggregation Program (MEAP) with industry leaders Merrill Lynch Wealth Management and Lincoln Financial. MEAP is a retirement plan solution that lets employers offer a competitive employee benefit that can also help reduce fiduciary and administrative responsibilities. This unique program leverages the strengths of group participation and a dedicated team of experts to implement a turnkey 401(K) program.







#### Eastern CT Manufacturing Pipeline

Provides no-cost training to address the hiring needs of Electric Boat (EB), members of the Eastern Advanced Manufacturing Alliance (EAMA), and other manufacturers. For job seekers, it provides several options: short-term classroom training, online manufacturing training, and job search assistance. This program is free to trainees and designed for unemployed and under-employed individuals.

#### Youth Manufacturing Pipeline Initiative

Building upon the MPI, the YMPI will raise the baseline of our labor force's competencies while aligning those skills to in-demand needs. The program aims to increase the availability of a manufacturing talent pool through the creation of a manufacturing-based career pathway for high school students after graduation.
